Capitol Rideshare is operated by the Arizona Department of Administration and is funded by the Federal Highway Administration through the Maricopa Association of Governments and by the Arizona Department of Environmental Quality.

Rules: Employees must be a non-university State employee in Maricopa County and participate at least one day during the Challenge Week. Participation consists of trips to and from work ONLY. A complete coupon must be submitted by the deadline. No credit given for sick or vacation days. Compressed work week day OFF is eligible. Alternate fuel vehicles are eligible ONLY if they are utilizing alternate fuel. Certain restrictions apply. If you need this information in an alternate format call 542-RIDE.

High Pollution Advisory Season

As we enter the winter season, remember that High Pollution Advisory Days (HPA) may occur.

This happens when carbon monoxide or particulate pollution reaches unhealthy levels.

On these days, avoid vigorous outdoor activity and make an extra effort to carpool, ride the bus, vanpool, telework or work a compressed work week (if available), bike, or walk to work. And don't forget to save those fires in your fireplace for another day.

If you are unsure if an HPA has been issued, there should be signs posted in and around your agency. If you are still not sure, check with your agency Travel Reduction Coordinator, log on to www.capitolrideshare.com, or call 602.542.RIDE.
